ORDER

The Government in G.O.Ms.No.1008/RD&LA Dept./
dated:29-06-'79 accorded administrative approval for providing
water supply schemes to Madachukulam Town Panchayat in Coimbatore
district at an estimated cost of Rs.22.16 lakhs to install and
Rs.0.88 lakhs to maintain annually. The scheme was completed
and handed over to the Madachukulam Town Panchayat during
August, 1984.

The revised estimate for this scheme was
prepared at an estimated cost of Rs.32.90 lakhs and cleared by
the Technical Committee in its meeting held on 13-03-'92. The
Board also in its resolution No.2.21, dated:07-10-'92 resolved
to recommend to the Government to approve the revised estimate
for Madachukulam Town Panchayat water supply scheme in Coimbatore
district for Rs.32.90 lakhs. The Madachukulam Town Panchayat
in its resolution No.136, dated: 21-04-'92 give its concurrence
for the revised estimate cost. The financial viability certifi-
cate is also received from Director of Town Panchayats.

The revised estimate was sent to the Government
for approval in letter dated:22-10-'92.

The Government in letter dated: 23-02-98 has
returned the revised estimate stating that the revised estimate
can be approved by Board as the estimate cost is within
Rs.10.00 Crores.
