Water Supply Scheme - Combined Water Supply Scheme to Aruppukottai, Sattur and Virudhunagar Municipalities - Administrative Sanction - Accorded - Orders - Issued.

ORDER:

The Hon'ble Chief Minister has made an announcement during the birth centenary celebration of former Chief Minister, Dr.M.G.Ramachandran on 23.10.2017 at Virudhunagar District that Combined Water Supply Scheme to Aruppukottai, Sattur and Virudhunagar Municipality with River Tamirabarani as source would be implemented.

2. The Commissioner of Municipal Administration has stated that the present supply is insufficient and the average per capita supply of Aruppukottai, Sattur and Virudhunagar Municipalities are only 50 Lpcd, 88 Lpcd and 56 Lpcd respectively. The existing Water supply could not serve the present population and far below the norms of 90 Lpcd. The Under Ground Sewerage System proposal will be taken up for Aruppukottai Municipality in future. Hence, in order to provide 135 Lpcd, it is necessary to formulate a Combined Water Supply Scheme to the above 3 Municipalities with River Tamirabarani as source.

3. The Commissioner of Municipal Administration has further stated that, as per the request of the urban local body, the Tamil Nadu Water Supply and Drainage Board has prepared the Detailed Project Report for Sattur Combined Water Supply Scheme with River bodies, Tamirabarani as source and submitted the Proportionate Cost as below:-

The Commissioner of Municipal Administration has requested the Government to allocate required fund of Rs.501.60 Crore as full grant as a special case through budget support for the project of Combined Water Supply Scheme to Aruppukottai, Sattur and Virudhunagar, so that these schemes can be implemented

and put in to use, as the above urban local bodies are highly water starved and are in need of separate water supply schemes.

5. The Government, after careful examination, have decided to accept the proposal of the Commissioner of Municipal Administration and to accord Administrative Sanction for the project of Combined Water Supply Scheme to Aruppukottai, Sattur and Virudhunagar Municipalities with River Thamirabarani as source at a cost of Rs.444.71 Crore (including 1st year of O&M amount of Rs.8.71 Crore) by availing 20% of the project cost of Rs.88.942 Crore under IUDM (Rs.44.00 crore in 2020-2021 and Rs.44.942 crore in 2021-22) and the balance 80% of Rs.355.768 Crore through a loan from Housing and Urban Development Corporation (HUDCO). The HUDCO loan will be drawn into the Water and Sanitation Pooled Fund managed by Tamil Nadu Urban Infrastructure Financial Services Limited and loan will be serviced by Government of Tamil Nadu. If necessary, guarantee will be provided by Government of Tamil Nadu.

6. The Commissioner of Municipal Administration is directed to place necessary proposal before the Project Sanctioning and Monitoring Committee under IUDM for sanction of Rs.88.942 Crore of IUDM share (Rs.44.00 Crore in 2020-2021 and Rs.44.942 Crore in 2021-22), in its ensuing meeting.

7. This order issues with the concurrence of Finance Department vide its U.O.No. 314/Prl.Secy (Expr.)/2019, Dated 13.11.2019.
