TWAD BOARD- REVISION OF WATER TARIFF TO THE CANTONMENT BOARD, St. THOMAS MOUNT FROM CWSS TO TAMBARAM PALLAVARAM IN KANCHEEPURAM DISTRICT.- ORDERS ISSUED

ORDER:

Cantonment Board, St. Thomas Mount located in Alandur Municipal area is one of the beneficiary of Tambaram – Pallavaram CWSS who have not remitted proportionate cost towards the installation cost of the scheme.

Since, there was no Government orders for fixing water tariff, the water charges to the Cantonment Board has been worked out and fixed by the then Superintending Engineer, Chengai – MGR Circle, at Rs.5.30/KL with effect from 01.04.1994.

Even though the water tariff revision was proposed twice (i.e.) at the rate of Rs.7.00/KL by the Chief Audit Officer, TWAD Board during 1998 and at the rate of Rs.15.00 for Industries and other beneficiaries based on G.O. Ms.No. 136/ MA & WS Department/ dt. 03.10.2002, they have been remitting the same rate of Rs.5.30/KL till the end of 2005.

Considering the special status accorded to the Cantonment Board as an autonomous Municipal body under Cantonment Act 1924,controlled by the Defense Ministry of Government of India, orders have been issued vide B.P.Ms.No.32/ dt. 30.01.2006 fixing water tariff at Rs.7.00/KL on par with the rate levied by Metro Water for Alandur area and to cancel the levy of 7.00/KL retrospectively from

01.04.1998 to 30.09.2002. Accordingly Cantonment Board has been remitting water charges at the rate of Rs.7.00/KL since 2006.

Now, the Board vide B.P. Ms.No. 88/ dt. 08.11.2017 has approved the revised water tariff as detailed below with effect from 01.11.2017.

The Cantonment Board have not remitted the proportionate cost for the installation of the scheme and hence it could not be categorized under the above classifications.

Since the rate of Rs. 7.00/KL fixed during 2006 is on par with CMWSSB rate, the proposal of fixing water tariff for the Cantonment Board, St. Thomas Mount, Chennai-16 at Rs.30.24/KL with effect from 01.11.2017 on par with the tariff rate of CMWSSB for Alandur Municipal area was placed before the Board in its meeting held on 26.6.2018.

The Board after careful consideration, in its Resolution No.2.34 dt. 26.6.2018 resolved as follows:

The Cantonment Board, St. Thomas Mount, Chennai-16 is presently supplied with 500 KLD of water from CWSS to Tambaram Pallavaram at the tariff rate of Rs. 7.00 per KL. Considering the special status accorded as an autonomous Municipal Body controlled by Defence Ministry, Government of India, water tariff was

previously fixed at Rs. 7.00 per KL Vide BP.Ms. No. 32, dt. 30.01.2006 on par with the water tariff of CMWSSB levied for Alandur Municipal area.

The Chief Executive Officer, St. Thomas Mount cum Pallavaram has requested to revise the water tariff of Rs. 11.00 per KL to Contonment Board as equivalent to Urban Local Body as per the BP.Ms. No. 32, dt. 30.01.2006

Now water tariff at Rs. 30.24 per KL has been proposed on par with CMWSSB rate for that area as previously fixed as per BP.Ms. No. 32, dt. 30.01.2006. The Chief Engieer, Vellore has also recommended this proposal and the anticipated revenue is Rs.27.21 Lakhs per annum due to provision of this connection.

Hence, the Board after careful consideration, **resolved to approve** the water tariff for the Cantonment Board, St. Thomas Mount, Chennai-16 at Rs.30.24/KL for supplying 500 KLD from CWSS to Tambaram - Pallavaram with effect from 01.11.2017 on par with the tariff rate of CMWSSB for Alandur Municipal area.

Accordingly the Board accords approval for the water tariff for the Cantonment Board, St. Thomas Mount, Chennai-16 at Rs.30.24/KL for supplying 500 KLD from CWSS to Tambaram - Pallavaram with effect from 01.11.2017 on par with the tariff rate of CMWSSB for Alandur Municipal area.
