**TWAD BOARD- REVISION OF WATER TARIFF TO ARIGNAR ANNA ZOOLOGICAL PARK, VANDALUR FROM CWSS TO TAMBARAM PALLAVARAM IN KANCHEEPURAM DISTRICT.- ORDERS ISSUED**

#### **ORDER:**

**Arignar Anna Zoological Park Vandalur** functioning under the control of Forest Department of Tamilnadu Government is a **non-profit organization of Government** made self sustainable by the way of entry ticket collection. This beneficiary is getting water (2.00LLD) from Tambaram-Pallavaram CWSS in Kancheepuram District and requested to levy the water charges as applicable to Government Hospital, Government Educational Institutions i.e. at the rate of Rs.30.00/KL.

During 2002, vide GO Ms. No. 136, MA&WS dt. 31.10.2002, orders have been issued for fixing the water tariff at the rate of Rs.15.00/KL for Industries and other beneficiaries. Subsequently the water tariff for Arignar Anna Zoological Park Vandalur has been reduced in GO Ms. No. 338 MA&WS dt 18.10.2004 at the rate of Rs.10.00/KL .

In BP Ms No. 88 dt.8.11.2017, TWAD Board have revised water tariff for all the beneficiaries under various classification. Accordingly, the beneficiary Arignar Anna Zoological Park, Vandalur have been informed to pay the water tariff at the rate of Rs.45/KL against the existing tariff paid at the rate of Rs. 10.00 /KL.

TWAD Board has revised the tariff rates for the Rural, Urban, and other beneficiaries in general after 15 years due to abnormal operational and maintenance gap raised between the expenditure and water charges collected.

However, the Government has approved previously at an lesser rate of Rs. 10/KL when the existing tariff was Rs. 15/KL for this beneficiary vide GO Ms. No. 338 MA&WS dt 18.10.2004, the proposal of fixing water tariff for Arignar Anna Zoological Park, Vandalur from CWSS to Tambaram - Pallavaram at Rs. 30.00/KL with effect from 1.11.2017 based on the request of Additional Principal Chief Conservator of Forest & Director, Vandalur was placed before the Board in its meeting held on 26.6.2018.

The Board after careful consideration, in its Resolution No.2.35 dt. 26.6.2018 resolved as follows:

The Arignar Anna Zoological Park, Vandalur is presently supplied with **200 KLD** at the tariff rate of Rs. 10.00/KL from CWSS to Tambaram - Pallavaram as per GO Ms. No. 338 MA&WS dt 18.10.2004.

The Additional Principal Chief Conservator of Forest & Director, Vandalur has requested to supply water at the tariff rate of Rs.30.00/ KL on par with the rate of Government Hospital, Government Educational Institutions, places of worship and Orphanages vide BP Ms. No. 88, dt.8.11.2017.

The Chief Engineer, Vellore has also recommended this proposal and the anticipated revenue is Rs. 10.71 Lakhs per annum due to provision of this connection.

Hence, the Board after careful consideration, **resolved to approve** the water tariff for Arignar Anna Zoological Park, Vandalur from CWSS to Tambaram - Pallavaram at Rs. 30.00/KL with effect from 1.11.2017 based on the request and facts furnished by the Additional Principal Chief Conservator of Forest & Director, Vandalur.

Accordingly the Board accords approval for the water tariff for Arignar Anna Zoological Park, Vandalur from CWSS to Tambaram - Pallavaram at Rs. 30.00/KL with effect from 1.11.2017 based on the request and facts furnished by the Additional Principal Chief Conservator of Forest & Director, Vandalur.
