### **ORDER:**

The Government vide G.O.(D).No.454/ MA&WS(DMC) dt.22.8.95., ordered the Board to take up 404 CWSS during 1995, for maintenance. It also contemplates that grant will be provided for maintenance of CWSS which will be recovered from the local bodies. Subsequently Government of Tamil Nadu vide G.O.Ms.No.21/RD/WS3 dt.22.1.97, have issued orders to take up the 5 Industrial Water Supply Schemes namely 20 MGD Water Supply Scheme, Tuticorin, 3 MGD Water Supply Scheme, Tuticorin, Small Arm Project WSS in Trichy, Regional Engineering College WSS in Trichy and DIP Avadi WSS in Chennai for maintenance w.e.f. 1.4.1997 as Board's own scheme. Further, Government of Tamil Nadu vide G.O.Ms No 83/ Dated 24.05.1998

ordered that, water tariff for the Board owned schemes may be fixed by Tamil Nadu Water Supply and Drainage Board itself in future. The track of tariff revision hitherto made is as below:

1). In G.O.MS.No. 136, MA&WS (WS4) dept dt.03.10.2002, the Government have fixed water tariff as follows.

RLB	: Rs. 3.00/kl
ULB	: Rs. 4.50/kl
Industries and other beneficiaries	: Rs. 15.00/kl

2) In G.O. MS. No. 338, MA&WS (WS4) dept dt.18.10.2004, the Government have issued orders revising the water tariff from Rs. 15/kl to Rs. 30/kl in respect of private industries/institutions, business and commercial organisation, private schools, colleges, hospitals etc., who have not paid proportionate cost of CWSS to TWAD Board.

3) Subsequently, TWAD Board vide BP Ms. No. 115, O&M Wing, dated 20.12.2006, the Board has issued orders revising the water tariff for the following categories of beneficiaries who have not paid proportionate cost of CWSS to TWAD Board.

4) In 2009 the Board has observed that the main beneficiaries of 20MGD WSS are drawing water for less than the allocated quantity and hence instructions were issued to collect fixed water charges for the 50% of allocated quantity, if the industry draw less than 50% of allocated quantity. But the industries dispute this claim and continue to remit the water charges only for the drawn quantity.

5) In BP Ms. No. 10. O&M Wing, dated 12.02.2014, the Board has issued orders revising the water tariff for the people Living Nagars / Residential colonies of Thoothukudi District which comes under 3 MGD WSS as Rs 15.00/KL. With the condition that the tariff will be revised in every 5 years with the cushion of 25% increase and rounded up to next ten rupees.

The Government approval has been sought for in Letter No. 230517 / F 31810 / JE (O&M) / 2017 dated: 6.6.2017 for implementing the revised water tariff as proposed in B.P.Ms.No. 47 dated: 16.05.2012. which is still under consideration. The gap between the maintenance expenditure and demand got widened year after year due to non-revision of Water tariff for the Urban and Rural Local Bodies after 2002 and Private Industries after 2006. The Board is dependent on the gap filling fund to defray the deficit in the maintenance expenditure.

In this light, water tariff revision for the beneficiaries of TWAD owned schemes becomes necessary utilizing the existing orders in G.O.Ms No 83 Dated 24.05.1998 which permits TWAD Board for tariff revision. Accordingly, the proposed revision of Tariff at least for TWAD Board owned Industrial water supply schemes was placed before the Board and approved as below vide **Resolution No 3.11:**

"The Board after careful consideration **resolved** to approve the proposed revision of Tariff for the TWAD Board owned Industrial water supply schemes as the tariff remain unchanged since 2002 (G.O.Ms NO.136.MA&WS(WS4)Dept dt.03.10.2002) and subsequently during 2006 (B.P.Ms No 115, O&M Wing, Dt 20.12.2006) for only those beneficiaries who have not paid any proportional cost for the project implementation. The details of the revised tariff applicable for each of the beneficiaries are itemized below":
