ORDER:

The Chief Engineer, Madurai has prepared a Detailed Project Report for Providing Combined Water Supply Scheme to Kandamanur and 15 Rural Habitations in Andipatty and Kadamalaikundu-Myladumparai Unions in Theni District, with River Mullai-Periyar as source, at a cost of Rs.5.20 Crore to install and Rs.0.20 Crore to maintain annually.

2. The proposal was cleared by the Regional Technical Committee in its meeting held on 22.11.14 and by the State Level Technical Committee on 24.11.2014.

3. The Board is empowered to accord administrative approval for the draft schemes costing upto Rs.10.00 Crores. Hence, the above proposal was placed before the Board in its meeting held on 29.07.2015. The Board in its Resolution No.2.4 dt.29.07.2015, after careful consideration, resolved to accord administrative approval to the proposal for Providing Combined Water Supply Scheme to Kandamanur and 15 Rural Habitations in Andipatty and Kadamalaikundu-Myladumparai Unions in Theni District, with River Mullai-Periyar as source, modified with a design period of 30 years, at a cost of Rs.5.50 Crore to install and Rs.0.22 Crore to maintain annually and to be implemented with funding under MNP/Any other GoTN Grant.

4. Accordingly, Administrative approval is hereby accorded to the proposal for Providing Combined Water Supply Scheme to Kandamanur and 15 Rural habitations in Andipatty and Kadamalaikundu-Myladumparai Unions in Theni District, with River Mullai-Periyar as source, modified with a design period of 30 years, at a cost of Rs.5.50 Crore to install and Rs.0.22 Crore to maintain annually and to be implemented with funding under MNP/Any other GoTN Grant.

5. The Chief Engineer, TWAD Board, Madurai Region, Madurai shall accord necessary Technical Sanction and take up the work after observing all formalities.



ORDER:

Administrative Approval accorded to the proposal for Providing Combined Water Supply Scheme to Kandamanur and 15 Rural Habitations in Aundipatti and Kadamalaikundu-Mayiladumparai Unions of Theni District with River Mullai -Periyar as Source at a cost of Rs.5.50 Crore to install and Rs.0.22 Crore to maintain annually and to be implemented with funding under MNP/Any other GoTN grant vide BP Ms.No.40 dt.31.7.15.

2. Subsequently, the above scheme was posed for approval of National Bank for Agriculture and Rural Development (NABARD). The National Bank for Agriculture and Rural Development (NABARD) had sanctioned a financial assistance under RIDF XXII (2016-17) for captioned CWSS is as follows:

3. Consequent on the sanction of NABARD Loan assistance , it becomes necessary to amend the above funding pattern in lieu of the existing MNP/GoTN, grant stipulated in BP Ms no: 40 dt 31.7.15 .

4. The proposal seeking amendment to the BP Ms.No.40/dt.31.7.15 concerning the funding for Providing Combined Water Supply Scheme to Kandamanur and 15 Rural Habitations in Aundipatti and Kadamalaikundu-Mayiladumparai Unions of Theni District was placed before the Board through Circulation.


