## ORDER:

- 1. The Chief Engineer, TWAD Board, Eastern Region, Thanjavur has prepared a Detailed Project Report for providing Combined Water Supply Scheme to Vellur and 24 rural habitations in Musiri Union of Trichy District at an estimated cost of Rs.322.60 Lakhs to install and Rs.7.20 lakhs to maintain annually under MNP.
- 2. The proposal was cleared in the Regional Technical Committee and Regional Scientific Source Finding Committee.
- 3. The detailed estimate was scrutinized and the cost worked out to Rs.322.60 Lakhs to install and Rs.7.20 Lakhs to maintain annually with per capita cost at Rs.2476/and cost per 1000 litres at Rs.10.40.
- 4. The Board is empowered to accord administrative approval for schemes costing up to Rs.10.00 crores. Hence, the above proposal was placed before the Board in its meeting held on 26.05.2010 and the Board in its resolution No. 2.18, Dated 26.05.2010 has resolved, after careful consideration, to accord administrative approval for the proposal for providing CWSS to Vellur and 24 rural habitations in Musiri Union of Trichy District at a cost of Rs.322.60 Lakhs to install and Rs.7.20 Lakhs to maintain annually with per capita cost at Rs.2476/- and cost per 1000 litres at Rs.10.40 and to implement the scheme under MNP funds.
- 5. Accordingly, administrative approval is hereby accorded for providing CWSS to Vellur and 24 rural habitations in Musiri Union of Trichy District at a cost of Rs.322.60 Lakhs to install and Rs.7.20 Lakhs to maintain annually with per capita cost at Rs.2476/and cost per 1000 litres at Rs.10.40 and to implement the scheme under MNP funds.
