ORDER:

1. The Chief Engineer, TWAD Board, Southern Region, Madurai has prepared a Detailed Project Report for providing Combined Water Supply Scheme to Sitharaevoo, Ayyankottai and 17 rural habitations in Authoor union in Dindigul District at an estimated cost of Rs.364.00 lakhs to install and Rs.5.40 lakhs to maintain annually.
2. The proposal was cleared in the Regional Technical Committee in its meeting held on 13.01.09.
3. The detailed estimate was scrutinized and the cost worked out to Rs.364.00 lakhs to install and Rs.5.40 lakhs to maintain annually with per capita cost at Rs.1726/- and cost per 1000 litres at Rs.11.37.
4. The Board is empowered to accord administrative approval for the schemes costing up to Rs.10.00 crores. Hence, the above proposal was placed before the Board in its meeting held on 02.03.2009 and the Board in its resolution No. 2.5, Dated 02.03.09 has resolved, after careful consideration, to accord administrative approval for the proposal for providing CWSS to Sitharaevoo, Ayyankottai and 17 rural habitations in Authoor union in Dindigul District at an estimated cost of Rs.364.00 lakhs to install and Rs.5.40 lakhs to maintain annually with per capita cost at Rs.1726/- and cost per 1000 litres at Rs.11.37 and to implement the scheme with 100% grant under MNP.
5. Accordingly, administrative approval is hereby accorded for providing CWSS to Sitharaevoo, Ayyankottai and 17 rural habitations in Authoor union in Dindigul District at an estimated cost of Rs.364.00 lakhs to install and Rs.5.40 lakhs to maintain annually with per capita cost at Rs.1726/- and cost per 1000 litres at Rs.11.37 and to implement the scheme with 100% grant under MNP
6. The Chief Engineer should accord necessary technical sanction and take up the work after observing all formalities.
7. The scheme on completion will be maintained by TWAD Board.
