Combined Water Supply Scheme to Alampalayam Town Panchayat, Padaveedu Town Panchayat including 669 Rural Habitations in Pallipalayam and Tiruchengode Unions in Namakkal District and Sankari Town Panchayats in Salem District with River Cauvery as source – Administrative Sanction – Accorded – Orders – Issued.

Order:

The Honourable Minister for Municipal Administration and Rural Development announced on the floor of the Assembly that a new Combined Water Supply Scheme to 669 habitations in Tiruchengode & Pallipalayam Unions including Alampalayam, Padaveedu Town Panchayat in Namakkal District will be formulated. Further during Dr. MGR Centenary Celebration on 17.09.2017 at Namakkal, the Hon'ble Chief Minister announced the implementation of the scheme by including Sankari Town Panchayat in Salem district.

- 2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in his proposal second read above has stated that, accordingly, investigation works have been taken up by TWAD Board and Detailed Project Report (DPR) has been prepared at an estimate cost of Rs.399.46 Crore. The new Combined Water Supply Scheme include Alampalayam Town Panchayat, Padaveedu Town Panchayat and 669 rural habitations in Namakkal District and Sankari Town Panchayat in Salem District. The project design contemplates 2020 as Base Year with Population / Demand projection computed for Intermediate stage at 2035 and Ultimate stage at 2050.
- 3. The Managing Director, Tamil Nadu Water Supply and Drainage Board has further stated that the total Project Cost of the scheme works out to Rs.399.46 Crore and Rs.900.31 lakhs for Annual Maintenance (AM). In the letter first read above, the NABARD has sanctioned this project under Rural Infrastructure Development Fund (RIDF) XXIII (2017-2018) and the loan sanctioned by NABARD for this Scheme is Rs.290.44 crore. The Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that the project may be implemented with the funding of NABARD

- **4.** The Board in its Resolution No.2.15 dated:24.11.2017 has resolved to recommend to the Government through Empowered Committee to accord Administrative Approval to the DPR for the above project at an estimated cost of Rs.399.46 Crore and Rs.900.31 lakh towards annual Operations and Maintenance with the proportionate cost and funding pattern as detailed at para-3 above.
- 5. The Empowered Committee has resolved to recommend to Government for according Administrative Approval to the Detailed Project Report for providing Combined Water Supply Scheme to Alampalayam Town Panchayat, Padaveedu Town Panchayat including 669 Rural Habitations in Pallipalayam and Tiruchengode Unions in Namakkal District and Sankari Town Panchayat in Salem District with River Cauvery as source at a cost of Rs.399.46 Crore and Rs.900.31 lakh towards annual Operations and Maintenance with the following proportionate cost and funding pattern:

6. The Managing Director, Tamil Nadu Water Supply and Drainage Board has therefore requested that the Administrative Sanction of the Government may be accorded in accordance with the resolution of the Empowered Committee as detailed at paragraph 5 above.

7. The Government after careful examination of the proposal of the Managing Director, Tamil Nadu Water Supply and Drainage Board have decided to accept the same and accord Administrative sanction for the project of providing Combined Water Supply Scheme (CWSS) to Alampalayam Town Panchayat, Padaveedu Town Panchayat including 669 Rural Habitations in Pallipalayam and Tiruchengode Unions in Namakkal District and Sankari Town Panchayat in Salem District with River Cauvery as source at an estimated cost of Rs.399.46 Crore and Rs.900.31 lakhs towards annual Operations and Maintenance with the following funding pattern:

The above sanction is subject to the condition that (i) the annual O&M cost for 5 years will be met out from the project fund by Contractors; (ii) after completion of 5 years, the scheme will be maintained by TWAD Board; and (iii) any escalation in project cost shall have to be borne by TWAD Board.

- 8. The Managing Director, Tamil Nadu Water Supply and Drainage Board is directed to pursue necessary action to place the above proposal before the respective CGF Committee for necessary sanction.
