## Order:

The Hon'ble late Chief Minister of Tamil Nadu, during the Collector's Conference, made an announcement that Combined Water Supply Scheme to 274 Habitations in Thanthoni Union of Karur District will be taken up for investigation. The Hon'ble Chief Minister during the MGR Centenary celebrations on 4.10.2017 has announced that the above work will be taken up for implementation.

- 2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in the proposal second read above, has stated that accordingly, Detailed Project Report (DPR) has been prepared by Tamil Nadu Water Supply and Drainage Board for the project of Combined Water Supply Scheme to 274 Habitations in Thanthoni Union of Karur District with River Cauvery as source.
- **3.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has further stated that the population projection is computed with base year as 2020, intermediate stage as 2035 and ultimate stage as 2050 respectively. The demand projection of water for the intermediate and ultimate period is made adopting a prorata supply of 55 lpcd. For the proposed Combined Water Supply Scheme to 274 habitations, a source in the Down Stream of Kattalai and 2.3 km in the upstream of Mayanur Barrage near Melmayanur, has been identified.

- **4.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that the estimate cost for the project is Rs.81.41 Crore for installation and Rs.178.00 Lakh for annual maintenance. The scheme will be implemented by funds from NABARD / NABARD State Share. The scheme on completion will be maintained by Tamil Nadu Water Supply and Drainage Board. The NABARD in the letter first read above, has approved a loan assistance of Rs.6768.54 Lakh under RIDF XXIV (2018-19) for this scheme.
- **5.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has informed that the Board in its Resolution No. 2.7, dated 26.6.2018 has resolved to approve the proposal of the Managing Director, Tamil Nadu Water Supply and Drainage Board to recommend to the Empowered Committee, for recommending Government to accord Administrative Approval for the project with an estimate cost of Rs.81.41crore to install and Rs.178.00 lakh to maintain annually and to implement with funds under NABARD / MNP.
- **6.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has further informed that the Empowered Committee in its resolution No.13.3, dated 20.9.2018 has resolved to recommend to Government for according Administrative Approval to the above proposal at a cost of Rs. 81.41 Crore to install and Rs.178.00 lakh towards annual Operations and Maintenance with the following funding pattern:

- **7.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has requested that based on the approval of the Empowered Committee as detailed at paragraph 6 above, Administrative Sanction of the Government may be accorded for the above project, so as to enable the Tamil Nadu Water Supply and Drainage Board to proceed with the implementation of the project.
- **8.** The Government, after careful examination of the proposal decided to accord Administrative Sanction for the project of "Combined Water Supply Scheme to 274 Habitations in Thanthoni Union of Karur District with River Cauvery as source" at an estimated cost of Rs. 81,41,00,000/- (Rupees Eighty One Crore and Forty One Lakh only) to install and Rs.1,78,00,000/- (Rupees One Crore and Seventy Eight lakh only) towards annual Operations and Maintenance (included in project cost), with the following funding pattern:
