ORDER:

In the letter read above, the Commissioner of Town Panchayats has stated that the Managing Director, Tamil Nadu Water Supply & Drainage Board has requested to give necessary concurrence to execute Water Supply Scheme to Gandhi Nagar Town Panchayat in Vellore District at an estimated cost of Rs.29.15 lakhs and necessary concurrence has been accorded in their office letter dated 20.11.2006. As regards funds tie-up, the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has been requested for providing necessary funds under Urban Infrastructure Development Scheme for Small and Medium Towns for taking up these projects.

2. The Commissioner of Town Panchayats has also stated that the proposal was placed before the SLSC for sanction of fund under Urban Infrastructure Development Scheme for Small and Medium Towns other than those proposals recommended to Government under the funding pattern of 80% of Central Government Grant, 10% of State Government Grant and 10% Town Panchayat Contribution and after examining the above proposal, the State Level Sanctioning Committee has sanctioned the loan cum Grant of Rs.26.24 lakhs to Gandhi Nagar Town Panchayats under Urban Infrastructure Development Scheme for Small and Medium Towns for water supply scheme at an estimated cost of Rs.29.15 lakhs as follows:

Government of India Grant	80%	-	Rs.23.32 lakhs
Government of Tamil Nadu Grant	10%	-	Rs.2.915 lakhs
Local body contribution	10%	-	Rs.2.915 lakhs

3. The Commissioner of Town Panchayats has therefore requested the Government to accord administrative sanction for the implementation of Water Supply Scheme to Gandhi Nagar Town Panchayat in Vellore District at an estimated cost of Rs.29.15 lakhs under Urban Infrastructure Development Scheme for Small and Medium Towns.

4. The Government after careful examination, accord administrative sanction for the implementation of Water Supply Scheme under Urban Infrastructure Development Scheme for Small and Medium Towns at an estimated cost of Rs.29.15 lakhs to Gandhi Nagar Town Panchayat, in Vellore District.
