Combined Water Supply Scheme to Uthangarai Town Panchayat and 50 habitations in Uthangarai union of Krishnagiri District from the infiltration well sources in the river Thenpennaiyar near pungampatti village of Kaveripattinam Union at a cost of Rs.28.24 crore – Administrative Sanction – Accorded – Orders – Issued

## Order:

The Hon'ble Chief Minister of Tamil Nadu, during the M.G.R. Centenary Celebration in Krishnagiri District on 23.9.2017, among others, announced that investigation works will be taken up to provide water supply to 425 Rural Habitations in six Unions namely Krishnagiri, Bargur, Uthangarai, Kelamangalam, Veppanahalli and Hosur with River Thenpennaiyar as source.

- 2. The Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that the present proposal of "Combined Water Supply Scheme to Uthangarai Town Panchayat and 50 habitations in Uthangarai union of Krishnagiri District from the infiltration well sources in the river Thenpennaiyar near pungampatti village of Kaveripattinam Union" is part of the above announcement.
- **3**. The Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that, the population projection is computed with base year as 2020, intermediate stage as 2035 and ultimate stage as 2050 respectively. The Demand is calculated at the rate 55 lpcd for rural and 90 lpcd for town Panchayat. The net demand works out to 19.82 LLD and 23.51 LLD for intermediate stage and Ultimate stage respectively. The River Thenpennaiyar is found to be the only perennial source to meet out the requirement for this Combined Water Supply Scheme. The area has been identified near Pungampatti village of Sellakuttapatti Panchayat in Kaveripattinam Union.

- **4.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has further stated that the project cost works out to Rs.28.24 crore (Rs.2824.00 lakh) for installation and Rs.50.00 lakh for annual maintenance. The Proportionate cost of Uthangarai Town Panchayat is Rs.1335.14 lakh for installation and Rs.22.07 lakh to maintain annually. The funding for the project will be NABARD /NABARD State Share. The Scheme on completion will be maintained by Tamil Nadu Water Supply and Drainage Board after the Contractor's maintenance period. In the letter first read above, the NABARD has approved loan assistance of Rs.2357.90 Lakh under RIDF-XXIV-2018-19 for the above scheme.
- **5.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has informed that the Board in its Resolution No.2.9, dated 26.6.2018 has resolved to recommend to the Empowered Committee for according Administrative Approval for the project, at a cost of Rs.28.24 Crore to install and Rs.50.00 lakh annual Operation and Maintenance with Proportionate cost of Uthangarai Town Panchayat Rs.1369.50 lakh and Rural Habitations Rs.1454.50 lakh respectively for installation and RS.22.07 lakh and 27.93 lakh respectively to maintain annually. It is also resolved to implement the scheme with NABARD/MNP/ other grants.
- **6.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has also informed that the Empowered Committee in its resolution No.13.2, dated 20.9.2018 has resolved to accord Administrative Approval to the above proposal at a cost of Rs.28.24 Crore (Rs.2824 lakh) to install and Rs.50.00 lakh annual Operation and Maintenance with the following funding pattern:

- **7.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has requested the Government that based on the approval of the Empowered Committee as detailed at Paragraph 6 above, Administrative Sanction of the Government may be accorded for the above project.
- **8.** The Government, after careful examination of the proposal of the Managing Director, Tamil Nadu Water Supply and Drainage Board have decided to accord Administrative Sanction for the project of "Combined Water Supply Scheme to Uthangarai Town Panchayat and 50 habitations in Uthangarai union of Krishnagiri District from the infiltration well sources in the river Thenpennaiyar near pungampatti village of Kaveripattinam Union" at a cost of Rs.28,24,00,000/- (Rupees Twenty eight crore and Twenty four lakh only)

to install and annual Operations and Maintenance cost of Rs.50,00,000/-(Rupees Fifty lakh only) with the following funding pattern:
