Order:

The Hon'ble Minister for Municipal Administration, Rural Development and Implementation of Special Programme, during the demand for 2017-18, has made an announcement that "Combined Water Supply Scheme to 138 Rural Habiations in Thottiyam Union of Tiruchirappalli District will be taken up for investigation". Subsequently, during the demand for 2018-19, the Hon'ble Minister announced that the above Combined Water Supply Scheme will be implemented.

- 2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter second read above, has stated that accordingly, Detailed Project Report (DPR) has been prepared for "Combined Water Supply Scheme to 138 Rural Habitations in Thottiyam Union of Tiruchirappalli District".
- **3.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that the population projection is computed with base year as 2020, intermediate stage as 2035 and ultimate stage as 2050 respectively. The demand projection of water for the intermediate and ultimate period will be 3.26 mld and 3.57 mld respectively. The source will be River Cauvery near varadharajapuram of Arasalur Panchayat in Thottiyam Union.

- **4.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has further stated that the estimate cost for the project is Rs.49.95 Crore (Rs.4995.00 Lakh) for installation and Rs.1.16 crore for annual maintenance. The scheme will be implemented by funds from NABARD / NABARD State Share or any other fund. The scheme on completion will be maintained by Tamil Nadu Water Supply and Drainage Board. In the letter first read above, the NABARD has approved loan assistance of Rs.4147.15 Lakh under RIDF-XXIV-2018-19 for the above scheme.
- **5.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has informed that the Board in its Resolution No. 2.2, dated 26.6.2018 has resolved to recommend to the Empowered Committee for according Administrative Approval for the above project with an estimate cost of Rs.49.95 crore to install and Rs.1.16 crore to maintain annually and to implement with funds under NABARD / MNP/NRDWP-SMS funding / or any other eligible grant.
- **6.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has also informed that the Empowered Committee in its resolution No.13.4, dated 20.9.2018 has resolved to accord Administrative Approval to the above scheme at a cost of Rs.49.95 Crore to install and Rs.1.16 crore towards annual Operations and Maintenance and to implement the scheme with the following funding pattern:

- **7.** The Managing Director, Tamil Nadu Water Supply and Drainage Board has requested that based on the approval of the Empowered Committee as detailed at paragraph 6 above, Administrative Sanction of the Government may be accorded for the above project, so as to enable the Tamil Nadu Water Supply and Drainage Board to proceed with the implementation of the project.
- **8.** The Government, after careful examination of the proposal of the Managing Director, Tamil Nadu Water Supply and Drainage Board have decided to accord Administrative Sanction for the project of "Combined Water Supply Scheme to 138 Rural Habitations in Thottiyam Union of Tiruchirappalli District" at a cost of Rs.49,95,00,000/- (Rupees Forty nine crore and ninety five lakh only) to install and Rs.1,16,00,000/- (Rupees One crore and sixteen lakh only) towards annual Operations and Maintenance with the following funding pattern:
